1. **Attendance :** 105 members as recorded in the attendance list were present in the meeting.
2. Brig Gen Mustafizur Rahman, ndu, psc (Retd), President of Baridhara DOHS Parishad presided over the meeting.
3. As the quorum was complete the President called the meeting to order.

Dear Honorable Members, Assalamualaikum

Warm Welcome to the 12th Annual General Meeting of our DOHS. At the very outset let us pray for the departed souls of our friends and colleagues who left us for eternal abode. May the Almighty Allah grant them the best place in Jannat. Ladies and gentlemen, during the last about 8 months of our tenure we held 11th AGM and a GM. Many of the points/observations have been considered by us.

During the last AGM, I mentioned that this Parishad intends to give priority in rendering good services to our members. Despite our sincere efforts we could not succeed in many areas. One of the most serious aspect surfaced is dealing with traffic congestion, controlling thoroughfare etc. We organized a seminar especially on traffic management in our DOHS on 17 Oct 2015. A good number of the members participated in the discussion. There were numbers of suggestions and finally majority opted for continuation of existing traffic circulation system. Of late the chaotic traffic situation has even worsened. We must find out a solution.

We have taken all kinds of measures including miking at the gates, physical checking by security guards at both ends of the main road and at most of the lanes. You may agree with me that traffic congestion in our DOHS is not an isolated phenomena. This is a spill over when traffic at Airport road gets jammed or when there is grid-lock at Gulshan-1 & 2 and Baridhara, Kalachanpur area. Our road is so narrow that a non-sticker vehicle is difficult to turn around, Honking from follow up vehicles starts even when security guards starts checking the vehicles. Other than thoroughfare our own 5,000 vehicles, hundreds of rikshaws, motorcycles, thousands of pedestrians, parking on the lanes, BSI & Annanay etc. all have compounded the traffic congestion in our mono street layout. I



am prepared to accept any good solution on our traffic system. Any one of you can sit with member Sy& Admin and discuss with him about the traffic solution.

Next, I like to talk on neighbourly relations among us. We are supposed to be the 'cream' of the society, all educated having high profile-socio economic status, leaders of the society etc. etc. But unfortunately there have been recently very ugly and indecent incidents like 'attempt' to thrash a neighbour on minor matters by hiring Gundas armed with Hockey Sticks and show of fire-arms. Police had to be called in to diffuse the tension. This is highly condemnable. I also like to mention that there are problems between sellers and buyers going for the last even 10-12 years, there are problems among tenants & Land lord. I think it is high time that we forget and forgive the petty trifling matters. Let us be good to our neighbors, show tolerance and be considerate to others. Same feeling of band of brotherhood as exists (less odd exceptions) among members of Armed Forces to be inculcated among all the diverse members of our entire community.

One of the major aspects I talked about in the last AGM was the protection of the bank of the pond. Through GM you have authorized me the project including the provision of fund. I have formed the committee with our EC members and some experts. But unfortunately the work is yet to commence due to various formalities and procedure. I am anxious that dry season will soon be over and construction work must commence ASAP. Likewise-Committee for Installation of lift, rides for the children, cinema projection formed. Let us listen to these committee members what they have to say.

Ladies and gentlemen-Security aspect of our DOHS has been heightened, elaborate close circuit camera has been planned, security guards have been increased. Through 'Service Center' we are trying to reach you and meet your requirements. We are giving due importance to environment and in future you will see more. Before the next new year you will find your DOHS going 'digital' in terms of providing/getting information. You are already getting free Wi-Fi at Convention center and Park area and more to come. Our Commitment to clean the 'cable-jungle' has been set on course. Dynamic Website of our DOHS is in the offing.


You will be able to get clear pictures of our total activities from the briefing of the Secretary.

6. The minutes of 11th AGM held on 31 Oct 2015 is confirmed by general body. Brig Gen Md Abul Hashim Khan, ndc, psc (Retd), House # 408/3, Road # 07 proposed to confirm the minutes which was seconded by Brig Gen Fakhruddin Haider, ndu, psc (Retd), House # 168, Eastern Road.

Agenda – 4: Presentation and Adoption of Annual Report of 2015

7. Secretary of the Parishad gave comprehensive report on the activities of the Parishad.

8. At the very outset Secretary conveyed his profound grief and condolence for the following members who have passed away in the year 2015. We convey our 'Doa' through monajat lead by our Imam :

9. The present committee took over the responsibility on 18 June 2015 from ad-hoc committee. The committee is working with their best of ability for the interest of inhabitants of our DOHS. To maintain the continuity of development works and other allied activities are in progress. Secretary chronologically present the activities carried out by our Parishad during the year 2015. These are as under :

a. **Security**: There were no major security breaches due to constant vigilance except very few minor cases of theft /burglary. However, Parishad has planned to bring whole DOHS area under the cover of CC Camera including mosque and its surroundings.

b. **Traffic System**: Vehicles of Gulshan, Banani, Baridhara areas use our internal road as shortcut way to bypass. We are more alert and strict now as regards to thoroughfare of unauthorized vehicles. We stop and return vehicles at the Y Junction which doesn't have any business inside DOHS area. This actions of our is temporarily causing inconvenience to the residents of Baridhara DOHS but being refused an entry through our gates people will refrain from using DOHS road as transit and we will have a hassle free better traffic system in future. We have taken serious view of blowing horns and overtaking, which have reduced but not fully stopped. We are trying our best in these regards.

- c. **Social Nuisance:** We detected anti social activities in one house where tenants used to carry out immoral business and we involved police to take care.
- d. **Minor Cases:** Security and Administration sub-committee has mitigated 33 cases of minor cases/irritants between to the house/flat owners and tenants, between belligerent neighbours or aggrieved parties.
- e. **Construction of Bank protection wall of pond.** The official formalities like planning, drawing & design, tender documentations, floating tender etc have been completed and awaiting for the start of construction. We expect that the construction work will begin within this month and likely to be completed within next couple of months.
- f. **Extension of Garbage Area.** The extension of garbage area is under progress and hopefully we shall be able to start the work after necessary approval from concerned authority. Meanwhile a point came from Brig Gen Ahmed Mukhtadir Arif, Imdc, psc (Retd) in last GM that a new garbage area may selected near Baridhara Gate instead of further extension of its present location. A team of officers headed by Air Cdre M Murad Hussain, ndc, acsc, psc (Retd) verified the proposal covering all aspects and found that the area is not suitable for garbage area due to paucity of land and other lacunas.
- g. **Vertical extension of CSD.** The work is under progress and likely to complete the work in this year. We are pursuing with authority to do the work at the earliest.
- h. **Recover of space from WASA.** The Convener, Capt M M Aziz, psc, BN (Retd) Utility Sub- Committee seriously pursuing with WASA to get back the occupied land of abandoned water pump areas at Rd 1 and Rd 13. It is expected that the area near pond and west end of Rd-1 will be handed over to us within couple of months.
- j. **Repair and maintenance work.** Cantt Board has been approached to repair the main road from school gate to Aannya gate with asphalt carpeting. Parishad carried out the repair work of pot holes all around road from sappers corners to Anannya gate. We also approached City Corporation for maintenance the road from Baridhara gate via 'y' junction to rail crossing near transit camp. A ramp constructed for seating for the people coming to deposit bills to AB Bank booth.
- k. **Progress work at Mosque.** The following works have been carried out :
- (1) Installation of AC at 1st floor.
 - (2) Construction of Stairway to 1st and 2nd floor.
 - (3) Brick paneling works have been done to avoid further erosion/damage of walkway in front of mosque.



- (4) One water dispenser installed at 1st floor.
- (5) Steel racks have been placed at ground floor for keeping religious books.

l. **Health-Hygiene and Sanitation.** The MI room has been geared up with more facilities to provide better treatment to patients. The cleaning of drainage systems are in progress and anti mosquito drives are also being carried out regularly to reduce the mosquito hazards. Drains under road will also be cleared very soon.

m. **Organising sports and cultural activities.** Parishad arranged inter DOHS basket ball competition with help sponsor named Nazmul Hassan Bhuiyan, Director, Zaastex Ltd and Baridhara DOHS became champion. We also participated in football and badminton competition. The other activities are shown below:

- (1) Celebration of Shaheed Dibash and International Mother Language Day 21 February.
- (2) Celebration of Bangla Nababarsho - Pahela Baishak.
- (3) Celebration of Victory day and reception of freedom fighters and arranged cultural night.
- (4) Arranged ladies club election for the first time and hope it will have continuation.
- (5) Eid reunion arranged by ladies club.
- (6) Yearly picnic arranged by ladies club for ladies only.

n. **Arbitration.** Arbitration Committee did a splendid job with hard work and patience hearing of aggrieved parties. They have been able to solve the problems by mutual understanding about 16 cases out of 20 cases. Two of the cases sent to AHQ and rest two cases are being solved.

o. **IT & Communication.** The Convener, Gp Capt M Rafiqul Huq, psc (Retd) relentlessly working to replace the wire jungles by fiber optics to provide better internet/dish service. The fiber optics lines are being arranged almost costing taka one crore (from the service providers). The work is under progress and likely to finish within few months. Meanwhile we have arranged free WIFI zone at pond area and Convention Centre by Aknet and Aamra respectively.

p. **Publication - Magazine.** A team of officers headed by Col Muhammad Golam Mustafa, psc (Retd) has done a commendable job publishing magazine named 'DIPSHIKA'. Parishad has decided that the magazine will be published end of each year.

q. **Seminar - Traffic Management.** The seminar on the subject has been arranged by Lt Col Bazlur Rahman (Retd), Member Sy & Admin on 17 Oct 2015. Participants were spontaneous on the subject and decisions so derived from the discussion are being practiced now.

r. **Seminar and distribution of the Holy Quran.** A seminar was arranged by Lt Col Md Shahidulla (Retd), Regional Director, South Asia, Al-Quran Academy, London on Dec 2015. A good nos of people participated in the seminar and it was well appreciated by all. We will be arranging few more seminar of such nature which will be very helpful for residents.

s. **Procurement of Fiber glass made play rides for Children Park.** A few play rides for the use of children already processed and being procured by cantt board. It expected that the items will be placed within next couple of months.

t. **Convention Centre :** Convention Centre is one of the major regular source of income of the Parishad. The net income earned after necessary expenditure being shared between Cantt Board and Parishad at the ratio 65 % and 35 % respectively. However, President made all out effort to change the ratio of sharing the income between Cantt Board & Parishad by 40 % and 60 % respectively wef from Feb 2016. Besides this above valuable change of ratio of earning the Parishad gave special attention to following activities for better result.

(1) Lt Col Md Abdul Khaleq, psc (Retd) has been appointed as coordinator.

(2) Decorator, caterer and floral contractors have been selected for terms two years 2016-2017 and necessary agreements were made accordingly.

(3) A detail policy regarding booking Halls for different categories of people have been finalized and approved by EC.

(4) Formulated policy/guidelines in details regarding Booking of Hall.

(5) A wide range of marketing facilities have been carried out through leaflets, use Tv scrole, placing sign board in important places, SMS by

RAOWA and Parishad giving advertisement in different magazine published by various institutions etc.

(6) Formulated the account policy on convention centre and account being maintained at their own.

(7) Repair and maintenance works are in progress like painting Boundary wall, pasting glossy paper in open glass, painting walls of Hall etc.

(8) The following major works are also in progress and mostly in planning stage and official formalities are being processed.

(i) To install lift.

(ii) Furnitures to be procured for convention centre.

(iii) To install Home Theatre for viewing movie.

10. Following proposals are placed before general body for approval.
- Construction of protection wall at pond area has been approved by the General Body which will cost approximately Tk 85 lacs or so - be approved.
 - Parishad has planned to purchase 136 x CC cameras costing approximately Tk. 10 lacs - be approved.
 - 3rd floor of convention centre is underutilized and rooms are not being used for months. An amount of Tk 10 lacs or so may be required for interior works including AC to make it rentable. This will provide us numerous facilities as well as financial dividend for long time.
 - Construction of 4th and 5th floor of convention centre may be under taken on BOT System (Build, Operate and Transfer). If agreed by the General Body a committee may be formed for evaluation and arranging interested party for which an amount of Tk 1/2 lac may approved as consultation fee.

14. The following points and suggestions received from Association Members.

a. **Point: Lt Col Md Abdul Khaleq, psc (Retd), House # 304, Road # 04**

Garbage removal : There is a big heap of garbage on the southern side of our garbage point near Anannya and on the western side of the road. This appears very ugly. These garbage should be cleaned and measure should be taken to develop some landscaping on the ground.

Koti: Koti issued to rickshaw pullers have worned out. Numbers on the koti has become deleted. Arrangement should be taken to issue new koti to rickshaw pullers.

Rickshaw Fare: There is a rate of rickshaw fare in the agreement with rickshaw contractors. But rickshaw pullers do not flow. They ask for more fare. The rickshaw fare as per agreement should be hung in the flowing places.

- (1) Johar Shahara poket gate.
- (2) Baridhara gate.
- (3) Transit camp gate.
- (4) Anannya gate.

Point: Maj M A Bashar (Retd), House # 486, Road # 08

পূর্ব পাশের ৮নং রোডের বাড়ীওয়ালাগুলো বিশেষ করে ৪৮৮, ৪৯০ ও ৪৮৬ নং এর পেছন থেকে শেওড়া বাজার এরিয়াকে প্রায় রাত্রে চোর ঢুকে। যদিও পেছনে রাত্রিকালে আমি বিশেষ করে এনার্জি বাল্ব লাগিয়ে আলোকিত রেখেছি। রাত্রি ১২০০ টা থেকে ভোর ০৫০০ টা পর্যন্ত দুশ্চিন্তায় থাকতে হয় কখন চোর ঢুকে। প্রায় ১.৫-২ মাস পূর্বে চোর ঢুকেছিল এবং কিভাবে চোর ঢুকে তাহা নিরাপত্তা অফিসার চীফ সুপারভাইজার সার্জেন্ট মোঃ রফিকুল ইসলামকে মোবাইল করে এনে আমি স্বচক্ষে রোডটি দেখিয়েছি। কিন্তু তাহা এখনো কার্যকরী হয়নি। উল্লেখ্য যে, ৮নং রোডে মেইন সড়কে রাত্রিকালীন ডিউটি কর্ণেল নাসির মহোদয়ের বাড়ীর সামনে সিকিউরিটির লোক দেখা যায়। তাহারাও বুঝতে পারে না চোর পেছন থেকে ঢুকে।

কাজেই ৪৮৮ বাড়ী (জনাব পাটওয়ারী) এর বাড়ীর পার্শ্বে পেছনে ওয়াল ঘেঁষা খালি জায়গা আছে। তাই এখানে একটি ছোট/মঝারী একটি সিঁড়ি জাতী টাওয়ার থাকলে এবং সিকিউরিটি ও টাইম যথা রাত ১০টা থেকে ভোর ০৬টা পর্যন্ত বসা থাকলে চোর কখনো ঢুকতে পারবে না।

সদয় ব্যবস্থা গ্রহণের জন্য অনুরোধ জানাচ্ছি। উল্লেখ্য ৯নং রোডের পূর্ব পার্শ্বে ১টি সিঁড়ি/টাওয়ার বক্স অব্যবহৃত অবস্থায় পড়ে আছে। এটাও এখানে ব্যবহার করা যায়।

Reply : Member Security and Admin has been asked to do the needful after physical survey. All possible measures will be taken against such activities.

Decision : General body accepted the reply of EC.

Point: Col Prof. Md Mosharrof Hossain (Retd), House # 216, Road # 02

a. **Monthly Subscription of Members (House owners/ Tenants):** Subscription for all houses should not be same. House/ flat upto 1200 - 1350 should be just half of the full house (1700 - 2700), or to be more precise it can be set based on the area/ size (sq ft) of the house.

b. **Svc Charge for Office Rent:** Present rate (small flat - 1000/- and large flat - 1500/-) should be changed to small flat be just half of large flat ie, Large flat - 1500/- and Small flat - 750/- . And that's what is most logical.

Most of the members/ flat owners being LARGE/ SINGLE House owners may not agree with my proposal, but pl try to understand the posn of only 2/ 3 small flat (1350 sft) owner like me.

c. **Clearing the Parking Area:** The parking area on the western side of CSD has not yet been cleared. One person's whim cannot be thrust upon all the inhabitants of DOHS. Ultimately it speaks on the weakness/ inability of the DOHS Parishad.

Why the Parishad with its hundreds of Sy Guards or by any other means can't through away that junk and bring comfort to the DOHS inhabitants.

Reply :

a. **Monthly subscription :** Owners and tenants enjoy the same available facilities provided by DOHS. The present rate of subscriptions are being practiced for long time, Expenditures of Parishad have increased in many folds

specially the enhancement of pay of employees. We are making all out effort to not to increase the subscription rather to continue with the present rate. As such the present system to continue.

b. **Subscription of office :** We acknowledge your proposal with profound feeling but difficult to change at the moment for reasons stated above.

c. **Clearing the parking area :** Lt Col Nasir Ahmed (Retd) promised to us that he would clear the construction material by Feb 2016 but failed due to some constraints and unavoidable situations as explained by him. These explanations are not acceptable. He has been asked to remove all materials by this month otherwise necessary actions will be taken as deemed fit.

Decision : Reply of EC has been accepted by General body.

Point: Capt (BN) M Omar Faruque, psc (Retd), House # 548, Road # 13

a. **Beautification and cleanliness:-** It has been observed that lot of nice gardens are coming up in and around Baridhara DOHS. But sorry to say that cleanliness of our area has not improved as expected. Cleaning party while carrying the waste by van, dropped lot of dirty items on the road. While cleaning the road they throw maximum waste and tree leaves in the open drain, which create lot of problems.

Suggestion:- More cleaner and Van may be used to improve state of cleanliness. Awareness may be raised among the inhabitant of DOHS.

b. **Smoking free area:-** Now a days many people are smoking here and there in open space violating Govt law. More over this smoking is hazardous for men and materials.

Suggestion:- "NO SMOKING" may be painted in the wall, specially at the lanes in the eastern side, particularly in Lane No. 12 and 13. Other appropriate visible walls also can be used.

c. **Painting / Marking parking areas:-** Many cars/micros are parking haphazardly near Mosque, Annanya shopping complex, BSI, Main gates and in Lane No. 13. It create nuisance and accident.

Suggestion:- Parking boxes may be painted / marked in designated areas, so that drivers can park their vehicle in appropriate place. This will reduce blowing horn problem also.

Reply: We have selected 04 (four) parking area like CSD area, Anannya parking area, Convention Centre parking area & Eastern Road as a whole, we are taking step to clear these area for parking, co-operation from members will help us reducing parking on road side.

Decision : Reply of Parishad has been accepted by general body.

Point : Col Zillul Majid (Retd), House # 397, Road # 06

a. **Blind corner :** Vehicles coming from lane 7 to lane 6 bi-lane, come with high speed which may cause accident. So safety measure may please be taken on that corner.

- b. **Motor Cycle** : Most motor cycles drive at high speed violating all traffic rules. First running Motors cycle may please be restricted as much as possible.
- c. Two additional guards are required to help guardian to manage traffic during open and closing of school.
- d. **Rickshaw** : Approximately 60% unauthorised Rickshaw playing at random. This may please be looked into.

Reply: Member Sy & Admin has noted the points and will ensure actions.

Decision : Agreed with the reply of Parishad.

Agenda - 8: To transact any other points with permission of President

15. The following points have been received from the members present during Meeting.

- a. **Brig Gen Fakhruddin Haider, ndu,psc (Retd), House # 168, Eastern Road.**

Point : Traffic problem inside Baridhara DOHS.

Reply: Parishad will arrange a separate seminar for traffic system.

- b. **Col Emdad Uddin Ahmed (Retd), House # 145, Road # 01**

Point : Speeding vehicles. He said that 3-4 nos sports car are plying during early late night around 2300 hrs or so which creates huge and unbearable are not expected. Parishad must take appropriate measure against such acts.

Reply: Member Sy & Admin has been asked to do the needful.

Decision : Agreed with the reply of Parishad.

- c. **Lt Col Ahmed Ali (Retd), House # 245, Road # 03**

Point : Maintenance of mosques is not sufficient.

Reply: Convener Mosque sub-committee has been asked for the needful.

- d. **Air Cdre Ishfaq Ilahi Choudhury (Retd), House # 365, Road # 06**

Point: Spitting on roads and around pond needs to be checked and cleaners much use hand Gloves while working. He also gave some suggestions.

Reply: Announcement in mosque will be done and bill boards will be placed at few places on above with other instruction also.

e. **Lt Col Syed Muhammad Kabir Uddin (Retd), House # 468, Road # 08**

Point : Unauthorised Small shop-Flexi Load, selling Cigarettes, Biscuits, Chocolate, Chips and other items are still going on within our DOHS causing naissance. He also suggested on traffic circulation.

Reply: We have called owners and also wrote letters to Cantt Board to stop this immediately. Member Sy & Admin will further initiate actions against defaulters. About traffic we will org separate round table conference.
