- 9. <u>To transact any other business with the permission of the</u> President:
  - a. <u>Sanction of Tk. 11,700/-:</u> Three security guards were arrested suspecting their involvement in the decoity case on 07 Nov 06 in the House No. 491 at Lane No. 8. They were found not

guilty and acquitted by the court. In the process Tk. 11,700/-(Taka Eleven thousand seven hundred) only were spent to plead the case and on account of medicine. The Member, Sy and Admin has put up the matter to bear the expenditure by the Parishad.

**Decision:** It was discussed and unanimously decided to bear the expenditure of Tk. 11,700/- vide PV- 402 dated 30 Nov 06 by the Parishad as the individuals were on duty at the time of occurrence.

b. **Purchase of Mob:** 4 × Mob sets (Nokia) were purchased at a cost of Tk. 15,600/- (Taka Fifteen thousand and Six hundred) vide money receipt No 696 dated 15 Nov 06. The Member Sy and Admin put up the matter for necessary approval by the Executive Committee.

<u>Decision:</u> Since it was essential for the security section, the Executive Committee unanimously approved the expenditure.

c. Expenditure on account of Bijoy Mela: Bijoy Mela – 2006 was held on 15 and 16 Dec 2006. An expenditure of Tk. 1,19,719/- was incurred. The Convener, Sports and Cultural Sub-Committee\_presented the statement of the expenditure and requested for necessary sanction.
