## MINUTES OF MEETING OF THE EXECUTIVE COMMITTEE (EC)

The points placed before the meeting in AHQ by the President are as under:

i.	Use of canopy and exhaust pipe by residents who have generators to curb sound and environmental pollution.	Cantt Board will take appropriate action against defaulters.
